Early registration deadline is August 30, 2025. Vendor spaces will be \$50 electricity will be an additional \$10. The number of spaces is limited so get your application and payment in as soon as possible. You will be required to be set up by 9:30 a.m. Saturday, October 4, 2025. Vehicles will NOT be allowed in the Festival area after 9:30 a.m. without permission from a festival official. Absolutely NO unattended vehicles may be left on the grounds the night before the festival. Vendors must provide their own tent, tables, chairs, power strips, electrical cords, tie-downs for the tent, etc. Each Vendor is responsible for leaving their vendor area in the same condition as it was originally received, i.e., removal of all debris, such as boxes and trash. This event occurs rain or shine! Be prepared for wind, rain, and/or heat and cold.

Vendor fees are **NON-REFUNDABLE** unless your booth has been denied by Shellman Beautification Association Officials. SBA has the right to deny any vendor. If denied there will be a full refund of vendor fees.
